#### **ELIGIBILITY:**

The objective of the CIRSA Law Enforcement Endowment Fund is to provide financial support to CIRSA members—beyond the current law enforcement trainings, roundtables, and resources CIRSA's Risk Control team already provides—to promote excellence in law enforcement practices and procedures, with the goal of reducing law enforcement risks.

To be considered for an award, the CIRSA member must submit a proposal outlining a project, process, improvement, or system which, upon establishment, will satisfy a law enforcement or risk management related goal. Examples include, but are not limited to:

Member employees may apply the award to a **professional development symposium** such as: the Colorado Association of Chiefs of Police (CACP) New Chiefs and Executive Leadership Training; the CACP Annual Conference; the International Association of Chiefs of Police (IACP) Annual Conference and Exposition; or any nationally or locally endorsed professional law enforcement-related conference.

**In-house trainings and webinars:** Bring the training to your officers, funding available if 80% of your police force participates.

**Recruitment services** to help your entity hire the high quality officers.

**Police-related equipment,** body armor, and/or riot gear and/or general equipment that ensures compliance with a CIRSA Risk Control Standard.

**SIGMA Tactical Wellness** – CIRSA provides provides funding for this program through another funding stream, this would be for additional officers to participate.

Funds to develop and communicate baseline **policies** or model policy committees.

**Simulator training** (moving target and firearms, driving, response to resistance decision making, use of force.

#### AWARD AMOUNT:

The CIRSA Board of Directors has allocated \$24,000. This amount may be awarded to a single CIRSA member or split among multiple CIRSA members at the discretion of the committee.

#### **RECIPIENT'S RESPONSIBILITIES:**

CIRSA will reimburse the <u>member entity</u> for expenses related to implementing the risk management/law enforcement project or program. Members must submit receipts for each expense incurred and will be reimbursed a maximum of the specified award amount. If the total award amount is not needed, unused monies will be kept in the Endowment Fund for future awards.

Recipients will be responsible for funding the expenses not covered or exceeding the Endowment Fund award. This award is not transferable and CIRSA will not provide reimbursement if the project is not accomplished.

#### **APPLICATION DEADLINE:**

Applications will be reviewed as they are submitted. All apllications must be submitted by **May 2, 2023.**
